## Rules & Regulations:

1. All entries must have negative coggins within 12 months. No coggins, no entry.
2. Show management reserves the right to add, cancel, or combine classes.
3. Goodwill and sportsmanship are essential for a fun and safe show. Management reserves the right to bar any animal, owner, or spectator for inappropriate behavior.
4. All youth entries in over fences classes must wear a helmet with a chinstrap. Safety wear in any class will not be penalized.
5. No alcohol permitted on GHPEC property.
6. Neither RVHA, BRHF, GHPEC, FCEC, nor any of its members, families, organizers, property owners nor employees, shall be held responsible for accident, damage, injury, or loss of animals, personal property, spectators, or any other persons on the show grounds.
7. A two (2) minute gate call and five (5) minute tack change will be enforced.
8. Dogs must be on a leash at all times.
9. You do not have to be a BRHF member to compete in a class. However, exhibitor must be a BRHF member prior to class entry if points won are to count toward year end awards.
10. Scratches must be made prior to start of class.
